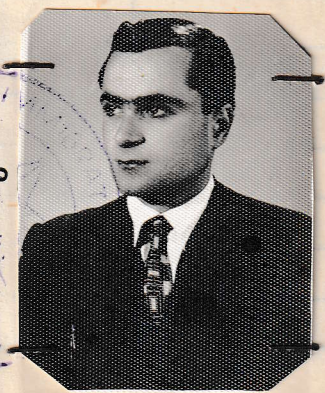

NOTICE TO HOLDER OF THIS CERTIFICATE

Should you change your permanent place of address you must within seven days of acquiring the new address complete a form "RA.2" and produce it with this certificate to the Commonwealth Migration Officer if residing in a Capital City or to the nearest Post Office at which money order facilities are available if residing outside a Capital City area. The new address will then be endorsed on this certificate. The same action must be taken if you are temporarily absent from your permanent address for a period exceeding thirty consecutive days.

Should you change your occupation or profession or the place of your employment, you must within seven days of such change complete a form "RA.3" and produce it with this certificate to the Commonwealth Migration Officer if residing in a Capital City or to the nearest Post Office at which money order facilities are available if residing outside a Capital City area.

Should you become a British subject by the grant of a certificate of naturalisation or by any other means you must complete a form "RA.7" and produce it with this certificate to the Commonwealth Migration Officer if residing in a Capital City or to the nearest Post Office at which money order facilities are available if residing outside a Capital City area. Your registration under the Aliens Act will then be cancelled.

Should you leave Australia you must surrender this certificate to the Immigration Officer in attendance at the vessel or aircraft at the time of embarkation.

The forms referred to above are obtainable at Commonwealth Migration Offices in all Capital Cities or outside Capital City areas at any Post Office at which money order facilities are available.

Your children if not British subjects must obtain separate certificates when they reach the age of 16 years.

Should this certificate become lost and be found by any person other than the person to whom it was issued, it should be immediately handed into the nearest Post Office or sent direct to the Commonwealth Migration Officer in the Capital City of the State in which it is found.

Failure to comply with any of the above requirements; making false statement with regard to registration or with regard to this certificate;

altering this certificate or any entry upon it; refusing to produce this certificate when legally required to do so; or

having in possession or using without lawful authority any forged, altered or irregular certificate or other document connected with registration;

will render the offender liable to a fine of up to £50 or imprisonment for three months.
